During the course of the preparation of your accounts for the period ending 28 February 2018, the following representations were made to us by the management committee. ## Representation

- You acknowledged as members that you have fulfilled your responsibilities in accordance with the applicable reporting framework for making accurate representations to us and for the accounts which we have prepared for the company.
- You confirmed that all accounting records had been made available to ourselves for the purpose of preparing the company's accounts and that all the transactions undertaken by the company had been properly reflected and recorded in the accounting records. All other records and related information, including minutes of all management committee meetings, had been made available to ourselves.
- You confirmed that the company had no liabilities or contingent liabilities other than those disclosed in the accounts.
- 4. You confirmed that there have been no events since the balance sheet date which required disclosing or which would materially affect the amounts in the accounts, other than those already disclosed or included in the accounts.

- 7. You confirmed that the company has not contracted for any capital expenditure other than as disclosed in the accounts.
- 8. You confirmed that this company has no related 51% group companies for tax purposes
  - a. You understand that companies are related 51% group companies if either
    - more than 50% of the ordinary share capital of one is beneficially owned (directly or indirectly) by the other, or
    - more than 50% of the ordinary share capital of each is beneficially owned (directly or indirectly) by the same company.
- 9. You confirmed that there are no laws or regulations that are central to the company's ability to conduct its business.
- 10. You confirmed that in your opinion the company is a going concern.
- 11. You confirmed the following specific representations made to us during the course of preparing your accounts:
  - a. The fair value of the investment property as at the period end was £345,000.
  - The split of fixtures and fittings from the purchase price of the property equated to £25,000.
